INDUSTRY HIGHLIGHTS

AEROSPACE



Houston remains a global leader in aerospace with significant advancements in suborbital flights, lower orbit missions, and deep space exploration. Companies like Venus Aerospace and Axiom Space are driving the future of space travel from Houston.

The development at Ellington Airport, called Houston Spaceport, with companies like Axiom Space and Intuitive Machines, is turning Houston into a hub for space innovation.

Houston's aerospace companies benefit from lower costs compared to competitors on the East and West Coasts, contributing to economic growth.

Exciting developments with funding include the Texas A&M Space Institute at NASA's Exploration Park, adjacent to the Johnson Space Center. **

BIOTECH



Houston's biotech sector is thriving with translational research, where academic research is rapidly being converted into startups, significantly impacting the city's economic growth.

Houston is emerging as a key player in biomanufacturing, with major companies like Lonza and Cellipont Bioservices establishing operations in the region.

The expansion of the Texas Medical Center's Helix Park is setting the stage for future biotech innovation, with cutting-edge facilities attracting top-tier talent.

ENERGY



Currently, Shell is working with Ferrari to develop new sustainable fuels for F1 cars. Al is accelerating the process as the models are fed data to allow the best iteration given the conditions provided.
